**Re: Project Financing Transaction to Coastal GasLink Pipeline Limited Partnership**

I write to request that you provide information about the project financing transaction to Coastal GasLink Pipeline Limited Partnership posted on Export Development Canada's "Individual Transaction Information" website.<sup>1</sup>

First, please advise when the transaction was published on EDC's website. While the listed transaction date of signing is June 27, 2024, I understand that reporting is posted only after signing and is not often done immediately.<sup>2</sup> Therefore, I would like to know on what date the transaction was posted online.

Second, please provide a copy of the decision that provides justification for entering into this project financing. I understand that pursuant to section 10.1 of the *Export Development Act*, EDC must consider whether a project is likely to have adverse environmental effects (despite implemented mitigation measures), and, if so, whether EDC is justified in entering into the transaction.<sup>3</sup>

Finally, please advise if notice of this transaction was published prior to the transaction being signed.
